# Jotmans Hall Primary School Pupil Premium 2020-21

The School receives funding to help all children who are entitled to receive means tested Free School Meals or who are Looked After by the Local Authority. This funding is called <u>Pupil Premium</u> and will be used to help children to make good progress in School.

Inside this leaflet you will see how we plan to use this money to support individual children and groups of children. We will look at each child and consider which initiatives will help them as an individual.

Our aim is to support families in a variety of ways - these vary each year according to the needs of families.

We hope that you will be very pleased with the range of support available and that your child will benefit from this initiative.



# Support within the School Curriculum

- Children in Year 6 will be targeted for any 1:1 tuition
- Children will be given extra reading support in class by staff or parent helpers.
- Children's homework will be monitored closely to see if they need to be invited to attend Homework Club
- Children's progress will be closely monitored by their Class Teacher and Senior Staff.
- Children will be targeted for any special groups.
- Children's attendance will be closely monitored by Senior Staff and any problems will be discussed with Parents/Carers.

The School will prioritise children and their families to see if the support of any Wellbeing Service would be useful to them.

### Support with Extra Clubs and Activities

### Support for School Residential Holidays

- We will pay 50% of the cost of the Year 4 Danbury Trip
- We will pay 50% of the cost of the Year 6 Stubbers Trip
- Parents must still complete the permission slip and return it to school.



### **Swimming**

• We will pay 50% of the contribution for swimming. Parents must complete the permission slip and return it to school.

### **Support for Day Trips and Visits**

 We will pay the cost of all School Day Trips and Educational Visits - parents must complete the permission slip and return to School.



### Free School Clubs

- We will pay 50% of the cost of one school club each term parents can pick from the club timetable each term.
- We may run special clubs to which individual children are invited these may be during the school day or at lunchtime.

### **Music Tuition**

- Children will receive a 50% subsidy for music lessons.
   Currently guitar, keyboard and drumming lessons are provided during the school day.
- Parents will be individually invoiced for the balance and must pay the balance to secure their child's place.



# Do you Qualify?

Parents or guardians receiving the following benefits can claim Free School Meals.

- Income Support
- Jobseekers Allowance (Income Based)
- Income related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- Child Tax Credit (provided you are not also entitled to Working Tax Credit and with an annual taxable income of less than £16,190)
- Pension Guarantee Credit
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1
   April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)
